- 1. Competitive offers are invited from all parties registered with BPCL Retail, Northern Region, for a financial limit of ₹ 20.00(Twenty) Lakhs & Above, for Upgradation of M/s Gorakhpur Auto Service at Gorakhpur, Distt Gorakhpur.
- 2. Based on the documents submitted by the bidders, shortlisting will be done for those who qualify the PQ Bid. Price bids shall be opened & considered for evaluation, for only those bidders who qualify the PQ Bids. A comparison of all such Price Bids shall be done to identify the L1 bidder and Job shall be awarded.
- 3. Tenderers are requested to carefully study all the documents / annexures, and understand the terms & conditions, specifications, etc., before quoting their rates. In case of doubt, written/ e-mail clarifications should be obtained, but this shall not be a justification for late submission of the bid or request for extension of due date. Offers should strictly be in accordance with the tender terms & conditions and our specifications.
- 4. All the supporting documents submitted by the tenderers should be legible, signed, stamped and attested by the authorized signatory as specified below in clause 7.
- 5. The authorized signatory shall be :
  - a) Proprietor in case of proprietary concern.




