### **INTRODUCTION**

Gas portal is another initiative by BPCL, which will help the gas customers of BPCL to enter their gas nominations and Re Nominations through internet. The portal will facilitate the customers to accurately enter the nomination/ Re nomination data and monitor their Annual Program on real time basis. Emails will be automatically generated/received upon confirming the data.

We believe that this portal will help the customer in daily planning of gas consumption. Detailed procedure and help documents are as follows



After entering the User ID (start with 'CC') & password, following screen will appear:-




### PROCEDURE FOR ENTERING THE WEEKLY DEMAND NOMINATION

Click on mYApplications->BPCL Natural Gas:-




System will open the following screen:-




• Demand Nomination: This option is available for the users to enter the Weekly Demand of Natural Gas.

Click on option 'Demand Nomination', following screen will appear:-



Select option 'Please select Contract', here system will show the Sales Contracts valid for the applicable Demand Week. Sales Contract details will be provided by the BPCL, Gas Department in advance.



Now click on option 'Show Nominations', following screen will appear:-



Against the Annual Plan Quantity, customers need to enter the weekly Gas Demand in the column 'Nomination - Delivery Point'. Quantities must be entered in unit 'MMBTU' only.

After entering the Weekly Nomination quantity, click on option 'Save Nominations'. With this option customers can change the quantity till the time 'Confirm Nominations' is selected.

Cusotmers can enter/change the Nomination-Delivery Point quantities for the next week upto Friday of the preious week (upto 1600 hours).

Once option 'Confirm Nominations' selected, system will not allow to change the quantities.

An e-mail will be triggered to BPCL once option 'Confirm Nominations' is selected. e-mail message will be as under which is from Customer to the BPCL Users.



#### PROCEDURE FOR ENTERING THE DAILY DEMAND RE-NOMINATION

Daily demand (Re-nomination) can be entered for the same Day & next Day - only upto 1600 hours on the same Day. Eg. If system is accessed on 25.06.2012, system will allow the customers to enter the Re-nomination for 25.06.2012 & 26.06.2012. Entry is restricted by 1600 hours on 25.06.2012.

Click on option 'Demand Re-Nomination', following screen will appear:-



Now Select the required Sales Contract and select the date also and then click on 'Show Re-Nomination'. Screen will appear as under:-



System will show the Annual Plan Quantity, Confirmed Nominations at Delivery Point & Imbalance quantity at Delivery Point. Here customer is required to enter the Renomination quantity for a day under column 'Re-Nomination - Delivery Point'.

After entering the Re-nomination quantity for a day, click on 'Confirm Re-Nomination'. Users will get the following e-mail message once re-nomination quantities are confirmed:-

### **IMPORTANT CONTROLS**

Following are the controls in the Gas Application:-

- This application can be accessed by only users who are registered in the BPCL Portal site.
- Demand Nomination on weekly basis is allowed only for the coming week (from Monday to Sunday) with day-wise break up.
- Demand Nomination on weekly basis can be entered from Monday to Friday of previous week. Entry can be made only upto 1600 hours on Friday (previous week).
- Demand Re-nomination on daily basis can be entered for the Same Day or Next Day only.
- Demand Re-nomination entry is restricted by 1600 hours on the same day.
